Genesis of the Washington, DC Chapter: During the last Chapter membership meeting, the Secretary stated there is a question concerning the genesis of the Washington DC Chapter charter. The charter currently in the possession of the Secretary states that Washington DC Chapter was established as a Chapter of the Association on August 13th, 1960. Manny De Jesus, the current Executive Secretary of the Association, has documents which refer to the existence of the Washington DC Chapter as far back as 1947. So we have a conflict on the origin of the charter and a number of individuals in staff and leadership positions within the Association are attempting to resolve the conflict. Chapter Chairman Ridley is requesting information from anyone who might have knowledge concerning the origin of the DC Chapter charter.

Wounded Warrior Program: Trooper Bob Elliott is the program coordinator. Bob states that he is working with SSG James Babin, the official liaison for 82nd Abn Div troopers admitted to the Walter Reed Army Hospital, to arrange for wounded warriors now in local military hospitals to attend the annual events and activities sponsored by the Washington DC Chapter, to include the monthly chapter membership meetings. Trooper Bob Elliott and Chairman Ridley plan to visit with SSG Babin and possibly some of the wounded warriors within the next few weeks to explore ways and means the Chapter can better accomplish the goals of the program.

Special Presentation by David G. Bolgiano: During the last membership meeting Chairman Ridley introduced Mr. David G. Bolgiano, an All-American Association and DC Chapter member who was a special guest speaker for the meeting and presented a program related to the Rules of Engagement

and the Use of Deadly Force. Mr. Bolgiano has served in Afghanistan, Qatar and Iraq as a legal advisor to the Commander, Special Operations Command Central. He is a former Army paratrooper and judge advocate.

An author, Mr. Bolgiano has written a book entitled *COMBAT SELF-DEFENSE: Saving America's Warriors from Risk-Averse Commanders and their Lawyers*. The book's external back cover reads:

“Warfare in the post 9/11 era has a new face. Enemy combatants may not be in uniform and could be hiding in villages filled with women and children or posing as dead bodies lying in the street. Soldiers have fractions of time to decide whether or not to employ the use of deadly force, balancing on a knife-edge of life and death. For many soldiers, the real battle begins after the fatalities in-theater—when lawyers get involved. Judgment and honor are called into question and hindsight applied to tactical decisions made in the heat of conflict.

An order form for Mr. Bolgiano's book is included as an attachment to this newsletter. Dave has indicated that he will return \$5 to the DC Chapter for each order (not each book) he receives from a DC Chapter member.

A sample letter is attached herewith as is the mailing addresses and phone numbers of the senators from the states in which the majority of the Washington DC Chapter members reside, Maryland, Virginia, Pennsylvania, West Virginia, Delaware and North Carolina. Those residing in states other than those listed should contact the Chapter Secretary for the names, addresses and phone numbers of their respective senators, or alternately, go to the Senate Web Page at www.senate.gov to find the name and address of your senators. Note that Senator Richard Burr of North Carolina is already a co-sponsor so his name is not listed. Our goal is to have SR82 passed prior to our Annual Convention in August.

Promotion for Past Division CG: Our former CG, MG William R. Caldwell IV, has been nominated for his third star and Commander of the US Army Combined Arms Center at Fort Leavenworth, KS. His current assignment is in Iraq and is frequently seen in the news delivering the command briefings.

Dear Senator (name of senator from your state):

I respectfully request that you co-sponsor Senate Resolution (S.Res.) 82, as introduced by Senator Chuck Hagel and entered into the Congressional Record on February 15, 2007.

There is no political agenda attached to it. Rather, it's all about recognizing the millions of American Paratroopers who have served this nation in both hot and cold wars since the U.S. Airborne Test Platoon made its first, official military parachute jump into American History at Fort Benning, Georgia on August 16, 1940.

American Paratroopers are now represented in each of our Armed Services. Current Army units include the 82nd Airborne Division, the Ranger Regiments, and the U.S. Army Special Forces. In addition, other services have the Navy SEALs, the Marine Naval Gunfire Control Teams and Reconnaissance Units and the Air Force Combat Control Teams that jump in with the lead elements of other airborne forces to mark drop zones, aircraft landing zones, and to control inbound aircraft to their drop and air land zones.

This is about the 4 million or so American Paratroopers who over the years have regularly put their lives on the line, who jump from aircraft with nothing but a small piece of nylon above their head and, once on the ground, fight to defend the freedom and national interest of America and the free world. From his first, official military jump on August 16, 1940 the American Paratrooper has been a "special breed" of war fighter who is feared by the enemies of this nation; respected by this nation's allies; and absolutely loved by the American people.

Last year (2006), Resolution 405 was passed and we received word and a residential Proclamation prior to our National Convention in August. We urge you to do this at your earliest convenience.

In view of the above, we would deeply appreciate your cosponsoring S. Res. 82.

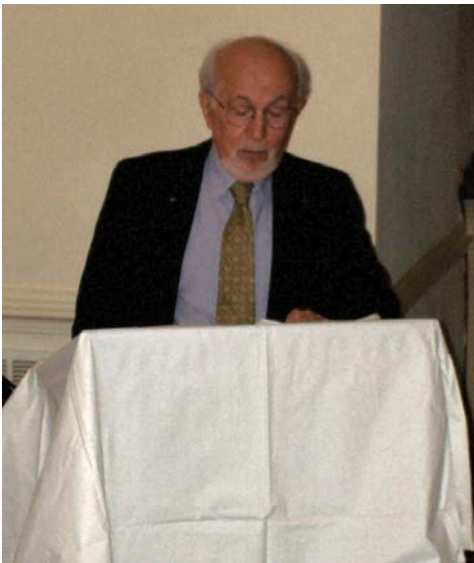
